A record of exceptional undergraduate teaching, evidence of outstanding scholarship, and commitment to liberal arts education as a foundation of business education are essential.

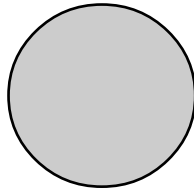
